### Who are we? Hello! This study team has medical doctors, people who study health care, "UNIVERSITY OF people with kidney disease, and other experts who care about people with kidney disease. The University of Aberdeen is organising this study. What is this study about? To hear people's experiences with having kidney disease, we are reaching out to patients from general practices and kidney clinics, and kidney patients' communities. We will also talk to staff working at general practices. We would like to hear about your experiences with having kidney disease or condition and the kidney care you have received. We will ask if you are okay with the rules for joining this study, which is called 'giving consent'. When giving consent, you will be asked if you agree to allow your kidney doctor to tell us your kidney health status, both now and at the time it was first recorded by your general practitioner (GP), including the date. This information will help us ask you relevant questions and explain our study findings. You can say 'no' to this and still join the study.


